## ORDINANCE NO. 99-01

AN ORDINANCE ORGANIZING AND CREATING AUXILIARY LAW ENFORCEMENT PERSONNEL FOR THE CITY OF GLENWOOD, PIKE COUNTY, ARKANSAS PURSUANT TO THE PROVISIONS OF ARKANSAS CODE ANNOTATED SECTIONS 12-9-301 THROUGH 12-9-308; PRESCRIBING OTHER MATTERS PERTAINING THERETO; AND DECLARING AN EMERGENCY

WHEREAS, Arkansas Code Annotated Sections 12-9-301 to 308, inclusive (the "Act") authorizes the City Council of a City of the Second Class to establish auxiliary law enforcement personnel; and

WHEREAS, the City of Glenwood (the "City"), has determined the need to establish an auxiliary law enforcement personnel for the purpose of maintaining police protection and patrol for the City; and

WHEREAS, the City is authorized by the provisions of the Act to organize and create the auxiliary law enforcement personnel for the City; and

WHEREAS, it has been determined that it is in the best interest of the City and its citizens and residents to organize and create the auxiliary law enforcement personnel;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLENWOOD, PIKE COUNTY, ARKANSAS:

SECTION 1: In accordance with and pursuant to authority conferred by the provision of the Act, there is thereby created and established a City of Glenwood Auxiliary Law Enforcement Personnel (the "Auxiliary Officers") with authority as hereinafter provided to act as law enforcement police officers.

SECTION 2: The name of the Auxiliary Officers shall be "City of Glenwood Auxiliary Law Enforcement Personnel".

SECTION 3: There shall be a minimum of one (1) auxiliary law enforcement officer for each full-time certified law enforcement officer employed by the City and no greater than one (1) law enforcement officer for each one thousand (1,000) persons in the political subdivision as determined by the latest official census.

SECTION 4: The auxiliary officers must meet the minimum standards

and training requirements as prescribed by the Arkansas Commission on Law Enforcement Standards and Training.

SECTION 5: The auxiliary officers shall be appointed by the Chief of Police and the Chief of Police shall supervise such officers and assign their duties.

SECTION 6: The City shall provide any and all uniforms and equipment necessary for the auxiliary officers to fulfill the duties requested of them by the City.

SECTION 7: The City shall provide liability insurance coverage on behalf of the auxiliary officers to cover any and all acts while performing official duties.

SECTION 8: All ordinances of the City or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 9: It is hereby found and determined that there is an immediate need for the providing of adequate auxiliary police protection, within Glenwood, Pike County, Arkansas, authorized to be provided under the Act, and that the creation of the Auxiliary Law Enforcement Personnel and the exercise of the duties and powers provided in this Ordinance are necessary for the preservation of the public peace, health, and safety. Therefore, an emergency is declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.
